# Coding Reference Guide for Measurement Year 2025 Follow-Up After Abnormal Mammogram Assessment (FMA-E)



# **Measure Description**

The percentage of episodes for Members 40-74 years of age with inconclusive or high-risk BI-RADS assessments performed October 3, 2024 through October 2, 2025 that received appropriate follow-up within 90 days of the assessment.

#### **Definitions**

Intake Period: October 3, 2024–October 2, 2025

**Episode Date:** The dates of service during the intake period when a high-risk or inconclusive BI-RADS score was documented.

BI-RADS Assessment: Clinically documented BI-RADS score. BI-RADS is a standardized classification system proposed by the American College

of Radiology, used for imaging of mammography, ultrasound. and MRI of the breast.

# The following codes meet the criteria:

High-risk and inconclusive BI-RADS Assessment during the intake period that received appropriate follow-up.

Appropriate follow-up is defined as either of the following:

A high-risk BI-RADS assessment result that received a breast biopsy on or within 90 days after the episode date (91 days total) (Category 4: Suspicious; Category 5: Highly suggestive of malignancy)
